2. **Release of Liability:** In consideration for being allowed to participate in dog training activities with Silent Creek Animal Training, LLC, I hereby release and hold harmless Silent Creek Animal Training, LLC, its employees, trainers, agents, and representatives from any and all claims, damages, losses, or expenses that I or my dog may incur while participating in these lessons. This waiver applies to any accidents, injuries, or illnesses that may occur during or as a result of training activities.
3. **Veterinary Care:** I acknowledge that in the event of an injury or illness that arises during in-person lessons (private or at a vet clinic), Silent Creek Animal Training, LLC is not responsible for the cost of any veterinary care or medical treatment my dog may require. It is my responsibility to ensure my dog is healthy and capable of participating in training sessions.
4. **Training Results:** I understand that dog training is not an exact science, and Silent Creek Animal Training, LLC cannot guarantee specific results or outcomes. I agree to follow all instructions provided by the trainer, recognizing that consistent effort and practice are required on my part to achieve desired training results.
5. **Behavioral Risks:** I certify that my dog is in good health and has no known aggressive behavior toward humans or other animals unless explicitly disclosed. I understand that if my dog exhibits aggressive or dangerous behavior during training, Silent Creek Animal Training, LLC reserves the right to terminate the training sessions. I will not hold Silent Creek Animal Training, LLC liable for the behavior of my dog during or after training.
6. **Virtual Lessons:** For virtual lessons, I understand that I am fully responsible for the environment and safety of my dog during training. Silent Creek Animal Training, LLC assumes no liability for incidents occurring during virtual lessons, and I assume all responsibility for any injuries or accidents.
